(Draft) PROVISIONAL PROSPECTUS

1. BACKGROUND/RATIONALE

Coastal waters of Southeast Asia are blessed with high productivity of fisheries resources because of rich ecosystems such as dense mangrove forests and seagrass beds sustained by rich effluence of nutrients from land, as well as extensive coral reefs with clean tropical sea environment. These areas are critical to a broad range of aquatic organisms during their life cycle from breeding, spawning, nursing and growing, hosting the feeding zones of aquatic species that are economically important, and serving as important source of recruitment of a wide diversity of fishery resources.

It is widely recognized that healthy marine environment is a prerequisite for sustainable marine fisheries production. Therefore, it is one of the most important responsibilities of fishery managers in the Southeast Asian Region to work for realization of good balance and relationship between human activity and coastal environment so that we can utilize marine fishery resources in a sustainable manner. However, commercially important fishery resources in the region have declined due to many factors that include overfishing, illegal fishing, use of destructive fishing practices, and environmental degradation. Massive clearance of mangrove forests for aquaculture, urbanization, industrialization, wood fuel, timber and the like, could bring about large temporary economic benefits to certain groups of people or governments but in the end, the breeding, nursery and feeding areas of many aquatic species such as fishes, crustaceans, and mollusks might be destroyed and lost.

In addressing such concerns, SEAFDEC has been conducting projects to promote resources enhancement through the following two approaches: one is through improvement of critical habitat/nursing ground of fishery resources, and the other is through direct enhancement of fisheries resources by artificial propagation techniques. And these approaches are being applied and implemented in most of the AMSs.

SEAFDEC had conducted the Symposium on strategy for Fisheries Resources Enhancement in Southeast Asian Region in year 2015 with the output to sharing knowledge and information on the implementation and lesson learned on the fisheries resources enhancement activities conducted by SEAFDEC and SEAFDEC Member Countries. Due to the delay project implementation in year 2016, SEAFDEC needs to adjust the project activities in year 2017 by organizing the Regional Expert Meeting Fisheries Resources Enhancement in the Southeast Asia with the objective to identify and

Meeting Fisheries Resources Enhancement in the Southeast Asia with the objective to identify and update the appropriate and effective resources enhancement tools and measures for fishery resources enhancement and habitats rehabilitation and conservation implemented by SEAFDEC Member Countries. In the meeting SEAFDEC will identify needs of each SEAFDEC Member Countries on the national implementation of fisheries resources enhancement programs and SEAFDEC activities on fisheries resource enhancement that plan to develop during 2018-2019 and it would be background information to develop for JTF-7 implemented from 2020-2025.

2. OBJECTIVES

- 1. Update the plan and implementation on fisheries resources enhancement national and regional program/activity;
- 2. Sharing information and lesson learned from activities on the of fisheries resources enhancement of SEAFDEC Member Countries and relevant organizations/agencies;
- 3. Follow up the management measures on fisheries resources enhancement activities in national level of SEAFDEC Member Countries; and
- 4. Identify the needs of SEAFDEC Member Countries on the national and regional implementation of fisheries resources enhancement program/activity.

- 1. National and regional information on the fisheries resources enhancement programs/activities implement carried out in Southeast Asia.
- 2. Information on the management measure of fisheries resources enhancement national level;
- 3. Scientist network on the resources enhancement works in SEAFDEC Member Countries
- Recommendation of SEAFDEC Member Countries the implementation of fisheries resources enhancement programs that could be SEAFDEC information and direction to develop activities to support MCs both short-term and long-term activities include direction to develop the SEAFDEC project implemented from 2020-2025.
