## PROFILE OF CAMBODIA

- Total area of 181,035 km<sup>2</sup>
- Coastline of the country is 435 km
- Population 15.33 million
- Literacy ratio 79.9%
- Life expectancy 68 years
- GDP: 16,780 million US\$ (1,116 USD/capita)
- Language: Khmer





# CAMBODIAN FISHERIES


- Many years contributed significantly to the employment and livelihoods of the poor, to food security, GDP and foreign exchange balance
- The marine sub-sector contribution about 20% to the total fish catch production
- Contribute 8-12% of GDP
- Fish consumption: 52.4 kg/capita/year
- Value at US\$200-300 million per year (at the point of landing)






Law on Fisheries 2006 and Amendment of Fisheries Law (2017)

#### Law on Fisheries

#### Marine Fisheries domain: Article 11

#### Regulations:

- Article 3, 12, 15, 19.1, 20.8.14, 21, 22, 23.1.2.3.4.5.6.7, 24.2.5.6.7.8.9;
- Chapter 6, 7, 11, 12, 13, and Chapter 13; and
- ✓ Chapter 9 (article 45 to 52).

- Marine fisheries management and conservation
- Licenses and authorizations
- Fisheries access
- Recording of fishing vessels
- Monitoring, control and surveillance




#### MARINE FISHERIES MANAGEMENT (Con-)

#### Proclamations

- The use of fishing logbook;
- Guideline of community fisheries;
- Management and conservation measure for endangered fish species;
- Technical order of fishing vessel management;
- Technical order on condition of transshipment of fish and fishery products, and landing of foreign vessel;
- Determination of family fishing gears;
- Establishment of marine fishery management area; and
- Registration of community fisheries (6 CFis).

### ACTIONS TAKEN TO ADDRESS IUU-Fishing

- Improve fishing fleet data collection and storage
- Amend current fisheries law
- Ratify and implement:
  - ✓ PSMA of FAO
  - ✓ UNFSA
- Develop and implement:
  - ✓ NPOA-IUU fishing
  - ✓ NPCI
- Marine Fisheries Policy Statement



# Capacity Building is Needed...!

Training of the Observers and Landing Office On port and at seas inspection, and PSMA. A feasibility study of VMS and AIS will be assessed during the development of the NPCI/MCS with the support from EU and FAO.

Shearing of information on catch, fishing vessel, gears and port inspection result/ report and shearing of experiences in the implementation of port state measures among ASEANmember states.
