



Royal Ordinance on Fisheries B.E. 2560 (2017)
https://www4.fisheries.go.th/dof_en/view_message/224 Inspection Measures Section 94. No person shall bring a non-Thai fishing vessel that has undertaken IUU fishing into the Kingdom. The Director-General shall have the power to publically issue a list of non-Thai fishing vessels that have undertaken IUU fishing based on the lists of IUU fishing vessels published by a foreign state or international organisation. Section 95. A non-Thai fishing vessel wishing to import aquatic animals or...
